## **Registration:**

- Application deadline is February 20, 2026.
- Space assignment will be made upon approval of a completed application and fee.
- There are no refunds once your payment has been processed.

## **General:**

- This is an outdoor event. Vendors are expected to participate regardless of weather conditions.
- Exhibits must be open to the public from 12:00 p.m. to 5:00 p.m.
- You are not guaranteed product exclusivity.
- All applicable sales, taxes, etc. are to be handled by the Vendor.
- The Vendor shall obtain, at their own cost, any license or permits as may be required by Federal, State, and local laws, ordinances, and regulations.

## **Setup/Takedown:**

- Vendor check in and setup will begin at 10:00 a.m.
- Water and electrical connections will NOT be provided.
- Vendors must bring their own tables, shelves, tents, chairs, or whatever is needed for proper display of items.
- All tents must be anchored with weights, NOT stakes, to withstand the elements of weather and collapse.
- No strapping to permanent fixtures, i.e., railings, light poles, and similar items.
- Personal and business vehicles must be offsite by 11:30 a.m. Only vehicles necessary for vending operations are permitted to remain onsite once the event starts. General parking will be available.
- All signs, tape, string, decorations, etc., must be removed before leaving the site.

## **Prohibited Practices:**

- No commercial sales.
- No music, microphones, or amplification devices of any kind will be allowed.
- No disposal of water, ice, grease, or any liquid on the grounds of the coliseum at any time.
- No lewd or indecent actions, conduct, language, pictures, or portrayals shall be included in the activity presented by the Vendor on the premises.
- No pets allowed on the premises.
